Once again, it has been a great year for Valley View. Our Medical, Dental and Behavioral Health providers saw 20,392 patients in 63,732 encounters and our pharmacy wrote 9,182 prescriptions this year.

Speaking of amazing staff, Valley View marked the end of 2016 and the beginning of 2017 with our second annual all-staff training and appreciation dinner. Last years' event was so well received that management and the Board decided to do a repeat in 2017. This year, training focused on a vision of better employee engagement and, to thank employees for their hard work

and dedication, Valley View staff went home with a nice company logo jacket.

This past year, Valley View added a six operatory dental clinic in Olympia and a 340B pharmacy in Chehalis. We have also started the process of remodeling our Raymond Clinic, through an Infrastructure Investment Program Grant from the Health Resources and Service Administration (HRSA). In addition, plans are underway to add Tenino Family Practice to the Valley View team this spring. Welcome aboard Dr. Jump and Tenino staff!

What else is in the year ahead? Valley View is expecting accreditation from the

Accreditation Association for Ambulatory Health Care (AAAHC), which means that Valley View meets or exceeds nationally recognized standards for quality of care and patient safety. Major kudos to our quality team for making this milestone a reality. We are also in the process of completing a three year strategic plan. This is especially important in an ever changing health care environment. As Medicaid moves to "pay for performance", for instance, Valley View will be ready to focus on this initiative.

2016 Highlights

- Opened our first 340B Pharmacy at our Chehalis Clinic in January.
- Received an Oral Health Service Expansion Grant to add dental services to our Olympia Clinic and began the remodel of the site for expansion.
- Launched a new and improved website.

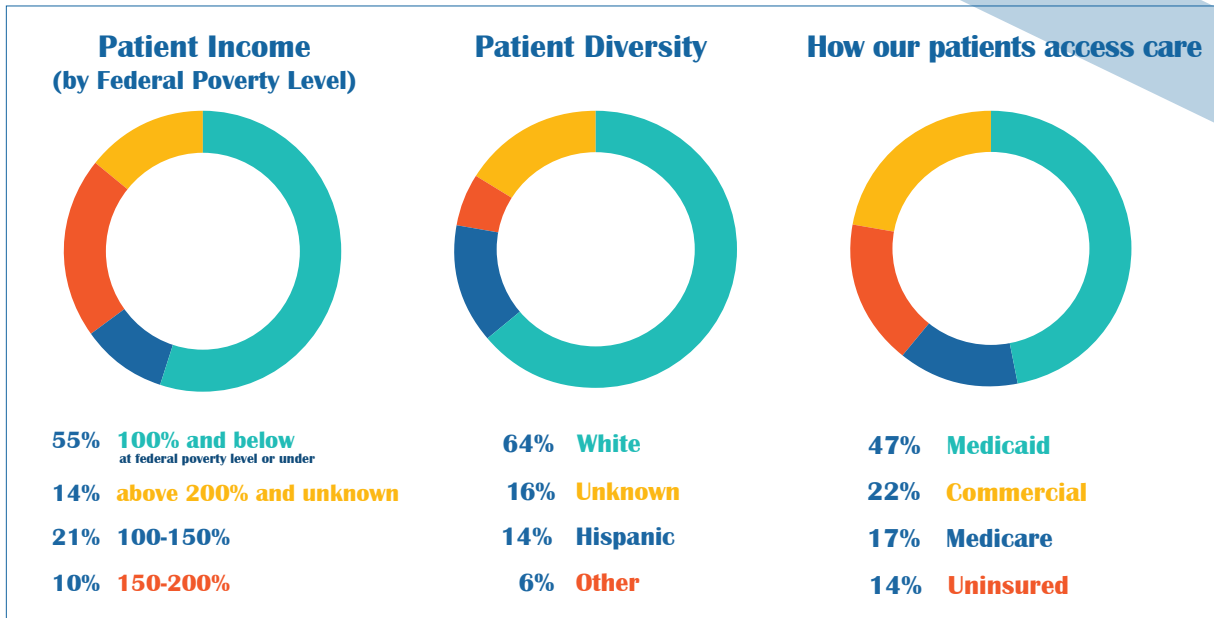

Our Patients

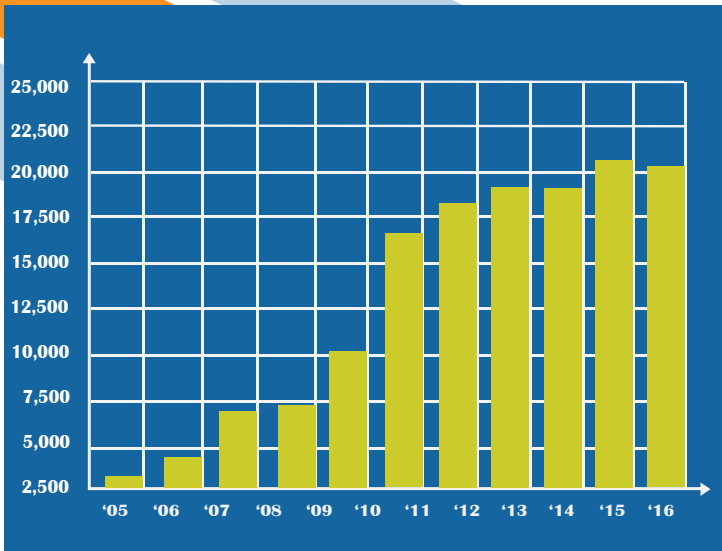

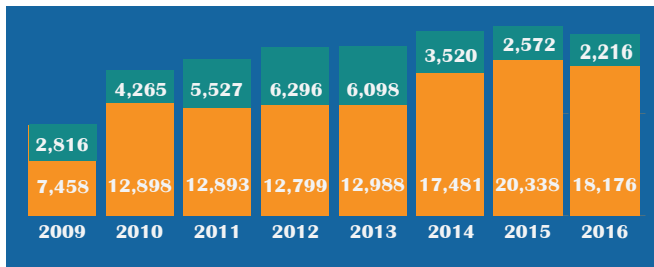

Medical Report

The need to reduce hospital emergency room visits for the uninsured was the major impetus behind the establishment of Valley View Health Center. The need for a safety net to provide health care to uninsured, low-income and medically underserved members of our community remains as true today as in Valley View's original inception in 2004.

A health care safety net in the community means that medical care is accessible to all, regardless of the ability to pay. This ultimately leads to healthier individuals and lower health care costs within a community. People are more likely to seek preventive care as opposed to frequenting hospital emergency rooms, and individuals with chronic conditions are able to receive consistent and regular treatment for their illness, thereby reducing the risk of complications and possible death.

Valley View Health Center provides an integrated, collaborative care model to health care service delivery. This means we treat the whole person and offer dental, behavioral health and pharmaceutical services to our patients, in addition to medical care.

As a physician, integrated and collaborative care is especially important for successful patient treatment plans. For instance, many of my patients are elderly, on a fixed income, and often have multiple, serious medical conditions. Through integrated care and a health safety net, I can offer behavioral health services to a depressed elderly patient and pharmaceutical services to an elderly Diabetic patient unable to afford insulin therapy.

Services provided by Valley View are especially pertinent today, with rising health care costs facing an uncertain and unpredictable future.

Dental Report

2016 marked an exciting and eventful year for Valley View's Dental Department.

The year began with the implementation of the Dashboard Quality Improvement Learning Collaborative. As one of five community health centers selected nationwide to participate in this pilot project, Valley View's dental team began the process of measuring 15 oral health metrics designed to improve quality in oral health care. Measurable quality metrics within the oral health arena is not well defined, especially when compared to primary care and the medical community. Valley View was invited to take part in a larger collaborative to extend these metrics to additional dental clinics across the county. Through generous support from the Washington Dental Service Foundation, in the amount of \$3,500, Valley View's dental team was able to participate in the larger collaborative.

Valley View Health Center was also the recipient of an Oral Health Service Expansion grant in 2016. This grant provides an additional \$350,000 in annual operating support for a dental clinic in Olympia. Valley View added six dental operatories and remodeled the medical clinic, allowing for an integrated collaborative care model of health care delivery for medical and dental, with future plans for behavioral health. Valley View saw our first dental patients at the Olympia Clinic in December 2016. The addition of oral health services at the Olympia Clinic marks the fourth Valley View dental clinic in twelve years. Could a pediatric dental clinic be next?

Behavioral Health Report

The Behavioral Health Department had some great moments in 2016. To begin with, we celebrated our one year anniversary offering behavioral health services at the Raymond Clinic. During the first year, behavioral health providers saw over 100 patients through a collaborative care model of service delivery and also began Screening for Brief Interventions and Referral to Treatment for substance abuse (SBIRT).

Another significant milestone was our success in the Social Innovation Fund Depression Treatment Program. We have treated over 450 patients since May of 2016. Due to the program's success, Valley View was featured in the John A. Hartford Foundation's 2015 Annual Report. The excerpt below, taken from the Foundation's Annual Report, illustrates the long lasting impact this grant has had on Valley View, our patients and the development of a collaborative care depression treatment program.

Perhaps most significantly, the success of the program has led Valley View to commit to sustaining the collaborative care approach once the Social Innovation Fund grant ends. The center's medical, behavioral health, and dental clinics are all linked so that someone treated for one problem can be immediately referred to help for another.

"It's so interwoven in everything we do," Dr. Normoyle says. "I work very closely with the other two clinical directors. It's about treating the whole patient and having that open communication. All of the support we've had from The John A. Hartford Foundation, all of the support and training we've had from the AIMS Center, has really helped us to demonstrate how a collaborative care program can work well, and how it can work well in such a rural state."

Pharmacy Report

Wow, what a year it's been!

As we celebrated our one year anniversary this January, I am struck by the amazing contribution that the pharmacy makes to integrated care and the benefit this service provides to our patients. This past year, we served 1,451 new patients! Many of these patients found it difficult to pay for their medications prior to the opening of the pharmacy. I remember one patient in particular. She was not able to follow-through with diabetic therapy which, in turn, led to an unstable condition because she could not afford insulin. Due to the lower drug pricing available through our 340B pharmacy, this patient is now on insulin and she and her provider are able to map out a consistent and beneficial treatment plan.

An exciting development for the pharmacy this year has been the implementation of a Refill Authorization Collaborative Practice. Pharmacists are able to review a patient's medication history and authorize a refill, following strict guidelines from the provider. This saves provider and nurse time spent on refill requests; it also increases patient safety by providing additional oversight on a patient's medication history. We are excited to expand this program throughout Valley View's clinics in the upcoming year.

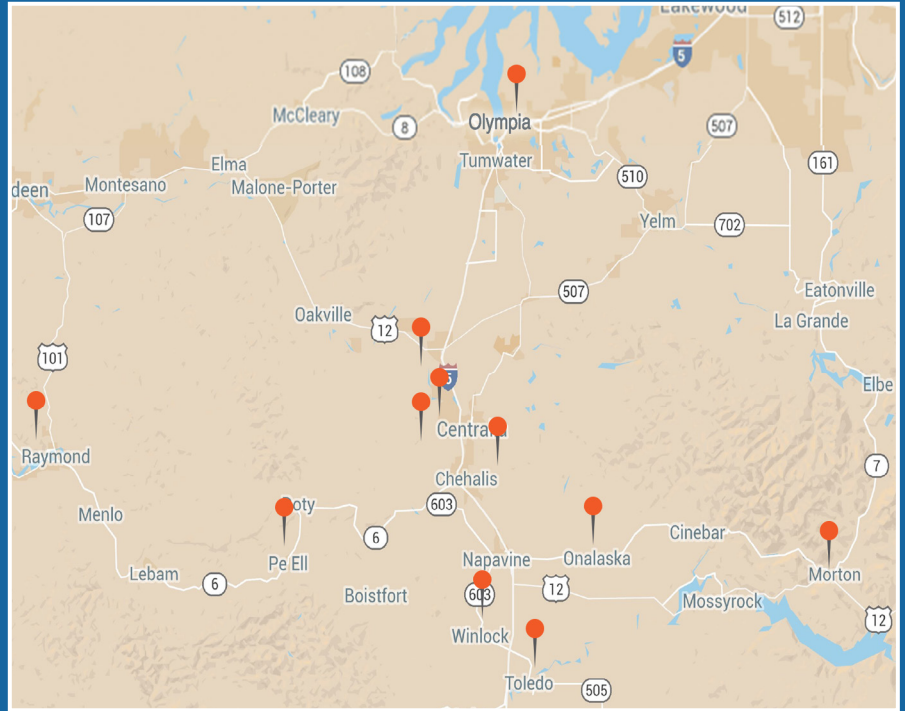
